#### Purpose of & Guide on how to use PAIA

The purpose of PAIA is to give effect to the Constitutional right of access to information. It grants a requester access to records of a private body, if the record is required for the exercise or protection of any rights. If a public body lodges a request, the public body must be acting in the public interest. Requests in terms of PAIA shall be made in accordance with the prescribed procedures, at the rates provided. The forms and tariff are dealt with in paragraphs 6 and 7 of the Act. In terms of section 10(1) of PAIA, the South African Human Rights Commission has made available a guide on how to exercise rights in terms of PAIA ('Guide'). This Guide is compiled in each official language and has been drawn up in an easily comprehensible form and manner. It is available at the below link:
